- As per the provision under Section 65 (4) of Maharashtra University of Health Sciences Act, 1998, I am directed to communicate the decision of the Academic Council taken in its meeting held on 27/05/2019. The Academic Council has unanimously resolved vide its resolution No. 57/2019 to grant Continuation / Extension of affiliation to the B.P.Th. course of your college for the academic year 2019-2020 subject to following conditions:
 - (a) The intake capacity shall be 40
 - (b) As per grant of permission from State Government (as applicable).
 - (c) Fulfillment of following deficiencies and submission of its compliance report within Three Months from the date of issuance of this letter:

- It is mandatory for the College to submit Affidavit in the prescribed format as per Academic 2. Council's Resolution No. 229/2013 (Format attached).
- Uploading of eligibility data within three months from the date of admission of first year students. 3.



- Colleges are required to carryout Permanent approval process of the Teachers who have been granted temporary approval upto 31st July 2019.
- To update Academic Online Teacher's Database of all teachers. On monthly basis review of availability of teachers shall be taken at College level & it shall be kept updated.
- Adequate facilities regarding Hostel and Library to be provided to the students.

- In case of any irregular admissions, University shall not be responsible for any academic or pecuinary loss or damages of the concerned.
